





## FUND MANAGER'S REPORT

Emerging market currencies sell-off continued this month albeit a tad abated with reduced risk aversion as trade war tensions between US and China intensified following US President Donald Trump's announcing a 10% tariff imposition on a further USD200 billion worth of imports from China, which will rise to 25% by year end. Meantime, the Federal Reserve raised rates for the third this year as expected to 2.25%, ushering 10 year US Treasuries to trade above 3% mark at month close.

Malaysia acknowledges signs of slower momentum to global growth as trade tensions contribute to downside risk. With that Bank Negara Malaysia (BNM) kept the Overnight Policy Rate (OPR) unchanged at 3.25% amidst absence of inflation threat. August Consumer Price Index (CPI) recorded a muted 0.2% year-on-year while Core inflation declined by 0.2%.

## FUND'S PERFORMANCE COMPARED TO BENCHMARK



Based on the Fund's portfolio returns as at 31 August 2018, the Volatility Factor (VF) for this Fund is 0.90 and is classified as "Very Low" (source: Lipper). "Very Low" includes funds with VF that are above 0 but not more than 1.885 (source: Lipper). The VF means there is a possibility for the Fund in generating an upside return or downside return around this VF. The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF for qualified funds. VF is subject to monthly revision and VC will be revised every six months. The Fund's portfolio may have changed since this date and there is no guarantee that the Fund will continue to have the same VF or VC in the future. Presently, only funds launched in the market for at least 36 months will display their VF and VC.
