### FUND MANAGER'S REPORT



Following US levy on washing machines and solar panels in January, a full blown trade war is now simmering after the latest imposition of steel and aluminium tariffs, threatening US-China trade totalling USD580 billion. This is said to punish China intellectual property theft and unfair investments in technology sector. Traders seek shelter by keeping US Treasuries in check with yields below 2.90%, drifting to a low of 2.74 at close of month despite the expected rate hike in Federal Reserve Funds rate by a quarter percent to 1.75%.

The less hawkish stance benefited Malaysian bond market with govies falling between 4 basis points and 14 basis points as we await announcement of the general elections.

### FUND OBJECTIVE



### FUND'S PERFORMANCE COMPARED TO BENCHMARK



Based on the Fund's portfolio returns as at 28 February 2018, the Volatility Factor (VF) for this Fund is 2.1 and is classified as "Low" (source: Lipper). "Low" includes funds with VF that are above 1.785 but not more than 6.045 (source: Lipper). The VF means there is a possibility for the Fund in generating an upside return or downside return around this VF. The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF for qualified funds. VF is subject to monthly revision and VC will be revised every six months. The Fund's portfolio may have changed since this date and there is no guarantee that the Fund will continue to have the same VF or VC in the future. Presently, only funds launched in the market for at least 36 months will display their VF and VC.
