



FUND MANAGER'S REPORT

The FBM KLCI gained 3.6% to close at 1,741 points in January 2026. Foreign investors emerged as net buyers, recording RM1.2 billion in inflows (Dec 2025: -RM2.0 billion).

Malaysian equities began 2026 on a strong footing, extending the positive momentum from end-2025. The market was supported by policy optimism, solid foreign inflows, a firmer ringgit, and improved liquidity. Sentiment was further lifted by Prime Minister Datuk Anwar Ibrahim's New Year address, which emphasized governance reforms and stronger policy execution, alongside better-than-expected 4Q25 advance GDP growth of 5.7%.

Domestically, the MADANI Budget 2026—the first under the 13th Malaysia Plan (RMK13)—anchors the next growth phase on fiscal discipline, inclusivity, and reform. With RM470bn in expenditure, a 3.5% fiscal deficit target, and reform-led revenue measures, the framework strengthens policy credibility while sustaining domestic demand through targeted subsidies and infrastructure investment. Foreign equity ownership in Malaysia also remains at historical lows, creating meaningful room for foreign inflows.

The Fund will continue to hold high-quality dividend yield names, particularly in financials, domestic REITs and utilities, while selectively accumulating oversold stocks during periods of weakness, focusing on companies with strong fundamentals and future-ready themes. Valuations remain compelling, with the FBM KLCI trading at ~16.1x PER, still below its long-term average.
