



FUND MANAGER'S REPORT

Malaysia's equity market ended 2025 on a strong note, with the FBM KLCI closing December at 1,680—its highest level since September 2024. While year-to-date equity performance still lagged global peers, the late-year rally reflected improving sentiment and rotation into underperforming markets. Notably, the Malaysian ringgit stood out as one of the strongest currencies globally in 2025, appreciating 10.2% against the U.S. dollar—the best performance among Asian currencies—underscoring Malaysia's relative macro resilience.

The December rebound was likely supported by emerging market carry trades as the U.S. monetary easing cycle gathered pace. The Federal Reserve cut rates three times in 2025, each by 25bps, bringing the policy range to 3.50–3.75% and reigniting risk appetite for emerging market assets. Having underperformed in 2025, Malaysia is well-positioned as a rotation candidate into 2026, supported by global liquidity tailwinds.

Domestically, the MADANI Budget 2026—the first under the 13th Malaysia Plan (RMK13)—anchors the next growth phase on fiscal discipline, inclusivity, and reform. With RM470bn in expenditure, a 3.5% fiscal deficit target, and reform-led revenue measures, the framework strengthens policy credibility while sustaining domestic demand through targeted subsidies and infrastructure investment.

We remain cautiously optimistic for 2026. Portfolios stay anchored in domestic recovery sectors—consumer, construction, and utilities—while selectively allocating to future-ready themes such as AI, semiconductors, and data centres. Valuations remain compelling, with the FBM KLCI trading at ~16.1x PER, still below its long-term average.
