





FUND MANAGER'S REPORT

Equities rose in April, with both Developed and Emerging Markets gaining. The U.S. 10-year Treasury yield dipped slightly to 4.16%, while the Dollar Index fell 4.6% to 99.5 on growing expectations of rate cuts.

Malaysia's FBM KLCI gained 1.8% to close at 1,540.2, rebounding after an early-month dip triggered by President Donald Trump's tariff announcement. Markets recovered following his 90-day pause on reciprocal tariffs and hints at negotiation. Telecom, consumer, and healthcare outperformed, while energy, transport, and tech lagged.

Malaysia also tracked the global rebound as trade tensions eased ahead of May 10 talks. Bank Negara Malaysia ("BNM") maintained its 2025 Gross Domestic Product ("GDP") forecast at 4.5%–5.5% and cut the Statutory Reserve Requirement by 100 basis points ("bps") to 1%, adding RM19 billion in liquidity. Positioned well under the China+1 strategy, Malaysia offers strong Foreign Direct Investment ("FDI") appeal. With the FBM KLCI's PER at 14.6x—below its 10-year average—our funds continue to accumulate on weakness via a barbell strategy, balancing oversold exporters and domestic plays.
