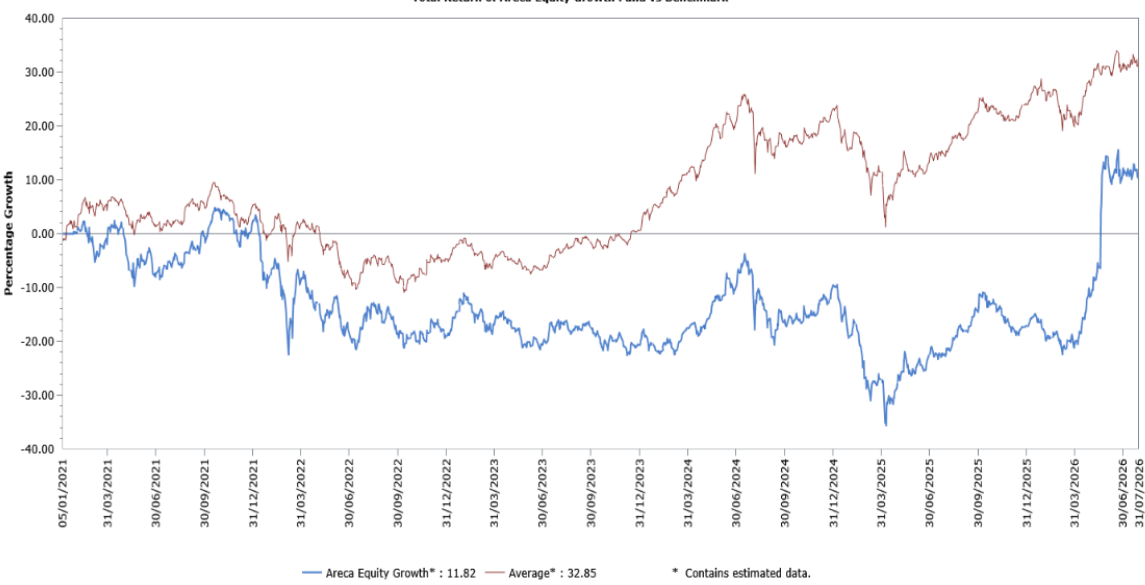

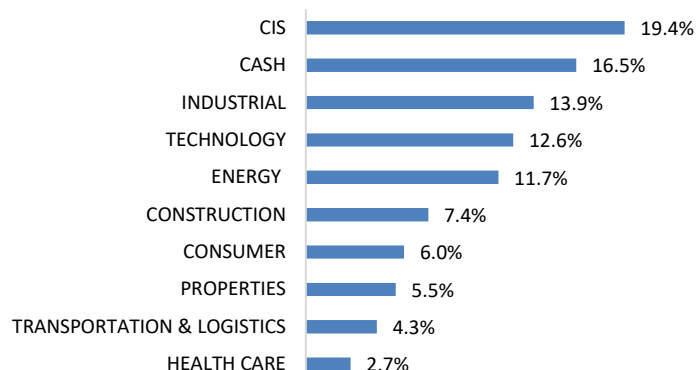

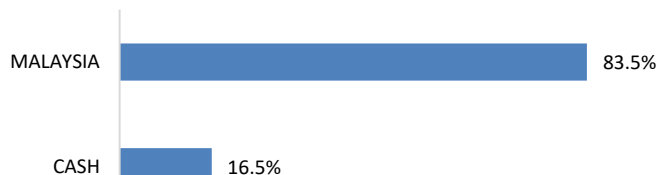

FUND MANAGER'S REPORT

The FBM KLCI gained 3.7% to close at 1,725 points in July. The broader market FBM Emas Index advanced 3.0% to 12,752 points, while the FBM Small Cap Index increased 2.0% to 15,707 points in the same period.

Foreign investors were net buyers in July, recording net inflows of RM264 million (June 2026: net outflows of RM2.4 billion). The FBM KLCI recorded its strongest monthly performance of the year, supported by improving domestic macroeconomic fundamentals, a return of foreign net buying and encouraging early corporate earnings. Sentiment was further lifted by Malaysia's stronger-than-expected 2Q26 advance GDP growth of 5.8% YoY.

The combination of a resilient Q2 GDP print, a stable policy rate, and the return of foreign buying, even if still selective, supports our constructive medium-term view, while the fragility of the Iran ceasefire warrants continued caution on near-term positioning.

Portfolios remain anchored in domestic recovery sectors, including construction, healthcare and utilities, while selectively allocating to long-term structural growth themes such as AI, semiconductors, and data centres. The fund has also locked in partial profits and rotated into large-cap names during periods of market weakness. Meanwhile, a healthy cash position is maintained to capitalise on opportunities in fundamentally strong companies when opportunities arise. Valuations remain compelling, with the FBM KLCI trading at ~14x PER, still below its long-term average.
