

FUND MANAGER'S REPORT

U.S. equities rebounded sharply in May 2025, buoyed by a breakthrough U.S.-China trade agreement that reduced most reciprocal tariffs from 125% to 10% for 90 days. The S&P 500 gained 6.3%—its strongest May in over three decades—while the Nasdaq surged 9.7%, and the Dow and Russell 2000 advanced 4.2% and 5.3%, respectively. Markets recovered to near record highs as risk appetite improved, supported by resilient earnings, record share buybacks, and moderating inflation.

Despite market strength, economic data remained weak. Q1 GDP contracted -0.3%, the first decline since 2022, sharply missing expectations. This undershoot heightened expectations for Fed easing, with markets pricing in 50–75bps of rate cuts from the current 4.25%–4.5% range. Valuations, which had briefly normalized, rebounded to roughly one standard deviation above long-term averages, leaving some vulnerability to policy or macro shocks.

With domestic growth concerns and elevated valuations, relative opportunities remain more attractive overseas. China, Hong Kong, and ASEAN markets offer lower valuations and stronger growth profiles, providing compelling alternatives for investors seeking diversification amid persistent global uncertainty.
